HIGH DENSITY POLYETHYLENE FOR FILM APPLICATION

HFG00246 is High Density Polyethylene Resin manufactured by IEPL using solution polymerization technique, “SCLAIRTECH” technology by Nova Chemicals. The resin offers medium molecular weight with broad molecular weight distribution. The grade is designed to produce high strength blown film of various thickness and can produce the film even < 10 micron. It can be easily processed on normal HDPE blown film lines, using melt temperatures between 200 and 230° C.
